While the Bogie and Sons proposal was hand written, it was drastically less expensive and seemed more serious, with far more detail than the C&K bid. The company also comes well recommended, as they are also repairing the roofs of the Museum and Sheriff's office. BF Builders will also be hired as a contractor to add an access hatch from the inside of the building.
